

## Communications

*Historia Universitatis Iassiensis* journal is published in a single number per year and includes studies and articles both in Romanian and in major scientific languages: English, French, German, Russian and Italian.

*Historia Universitatis Iassiensis* journal is an academic publication, with sections devoted to studies, historiographic articles, reviews, bibliographic notes, academic reports and essays and other categories of technical and administrative materials. Their theme is circumscribed to the issue of the university history, in general, and to the Central and Eastern European university in particular. The comparative approaches and theoretical studies regarding the university's history and historiography are welcomed and encouraged. At the same time, major attention will be paid to studies and articles related to the history of education and intellectual life, insofar as they significantly relate to the history of university. Along with historiographic contributions, the journal also encourages approaches on university museology.

As a rule, the editors do not impose any political, institutional and cultural restrictions. Critical attitude, debates and polemics are encouraged. However, the authors are advised that, in addition to necessary decency, to respect the fundamental values and norms of a democratic political culture. Contributions that praise anti-Semitism and hatred out of cultural or political reasons are excluded from the beginning. At the same time, studies and articles that approve totalitarian or non-democratic topics or behaviors are to be treated as noncompliant with the editorial line of the publication.

There are no time limits or strict indications regarding the structure of the texts submitted for publication. However, the journal will label as *studies*, and, therefore, published in a predetermined section, the materials that meet the following standards: a) Deal with a clearly stated problem in a quasi-exhaustive manner; b) Bring significant contributions to the issue in question; c) Meet the formal rules of an academic approach,

in terms of language, organization of the material, system of argumentation, ethical norms etc.

A special column within the publication is dedicated to *documentary* studies. These studies aim to disclose unknown or unpublished materials, regarding the history of university and academic life. They have to comply with the above-mentioned norms, to which formal rules of document editing are added; thus, the material sent for publication should contain: 1) A transcript of the original document; 2) The translation of the summary.

*Bibliographical essays* do not require strict demands of editing, in addition to the basic condition that the subject matter be significantly related to the general theme of the Journal. The reviews must deal with recently published works (during the last five years) and provide a professional critical perspective. Translations are not to be reviewed except for very well argued cases. Contributions for *Addenda et Corrigenda* must relate to a specific issue and not explicitly contribute to the correction of a historiographical error.

Studies and essays do not have a limited number of pages, but abuse is not encouraged. A study can not go over 30-35 pages, in size 12 font, except for very well argued cases, by the logic of academic exposure. If the number of pages is too big, the text can be published in several consecutive numbers of the journal. On the other hand, the reviews can not be less than 5 pages or over 10 pages long. Similarly, bibliographical notes should be between 2 and 4 pages long, with the same format. The contributions under the heading *Addenda et Corrigenda*, should not exceed 4-5 pages, respectively 1,500-2,000 words. Reports and essays under "Academic Life" can not exceed 3-4 pages, respectively 1,500 words.

The journal accepts for publication only material written in observance of the unanimously enforced academic rules; thus, for those in Romanian, the rules and regulations of the Romanian Academy are to be followed, and for those in foreign languages, the editorial norms in use for each language are required (e.g. for English, those contained in *Chicago Manual of Style*: <http://www.chicagomanualofstyle.org/toolscitationguide.html>).

All *studies* must necessarily contain a summary in a language other than the articles' and a self-presentation of the author (minimum personal data, academic experience, significant publications in the field). The studies may also include annexes, with documentary materials.
